Foreword

The success of any organization is dependent upon the spirit, pride, leadership, teamwork, dedication, and cooperation of its members. Certain rules, policies, and procedures are necessary so that the overall goals of the group are met, and the welfare of each individual member is best served.

By accepting membership in the Rouse Band, you are agreeing to perform to the best of your abilities and work together with the band staff in making this year's band the finest musical organization that our combined efforts can produce. In order for this to occur, students will need to be responsible, attentive, respectful, have a positive attitude, and follow the LISD Ten Ethical Principles. The directors will do their best to ensure that every student will be provided the opportunity to be successful, regardless of their ability as an incoming student or of their career ambitions following graduation.

The Rouse Band staff has developed this handbook to familiarize each band member with general operation and procedures of the Rouse Band and standards by which all band members are expected to conduct themselves. The handbook is not intended to be all-inclusive, as every possible situation and question cannot be predicted in advance; however, a thorough knowledge of these materials is essential to the smooth operation and success of the band this year.

Mission

Excellence from Within: Providing students with life changing opportunities for self-improvement through the endless pursuit of excellence in music performance.

Goals and Objectives

Mental and physical discipline

- Develop powers of concentration
- Memorize music
- Learn techniques of preparation as they relate to group and individual performances
- Develop self and group discipline

Citizenship through group endeavor

- Develop leadership abilities
- Develop responsibility
- Develop ability to cooperate with others and to work as a team member
- Develop diligence
- Develop mutual respect

Physical conditioning

- Develop strength, stamina, endurance and coordination

Cultural growth

- Provide opportunities to attain knowledge of music history through performance of various types of instrumental literature.

Value Judgments

- Ability to make musical value (as they pertain to a musical setting) judgments through critical listening. The student will recognize quality of sound, pitch, style, tempo, rhythm, blend, balance, phrasing, dynamics, and articulation.

Music theory

- Know and utilize note values and rest
- Know and utilize keys, key signatures, and scales
- Know and utilize musical terms, signs, and symbols
- Recognize and tune intervals and harmony
- Ear training/listening skills

Proper instrumental technique

- Care of the instrument
- Assume correct posture and playing position
- Develop the embouchure/stick grip/hand position
- Develop characteristic instrumental tone
- Develop proper breathing techniques
- Develop technical instrumental proficiency (fingering, articulation, rudiments, scales, etc.)

Creative self-expression

- Express oneself in every performance experience
- Explore careers

In addition to the State of Texas guidelines, the Rouse High School Band will strive to:

- Provide any interested student with opportunities for musical knowledge, musical fellowship, and fun through participation in band.
- Provide for the mental, physical, social, and emotional development of students.
- Instill pride and discipline in each student.
- Provide each student with solo and group endeavors to achieve personal goals and satisfaction.
- Provide basic psychological needs such as recognition, belonging, self-respect, and a feeling of achievement.

Communication

The directors encourage positive communication and are willing to discuss any aspect of a student's progress in band with his/her parents. Specific directors' e-mail addresses can be found on the band website. E-Mail is the primary form of communication for all band staff members.

General band updates and events are also managed through an app called "Band." Instructions to sign up will be provided prior to the beginning of each school year.

Conduct/Expectations

Band is a full-year commitment. Discontinuing participation in the program within the current school year is not an option unless approved by the band staff.

Band members will observe all policies set forth by Leander ISD, in addition to the following, as they pertain to the instrumental music setting:

General Guidelines

- Any behaviors, in both public and private events, that are not representative of good citizenship, as perceived by the band staff, may result in the student's dismissal from the activity at hand as well as the band program. This also applies to the actions of student leaders in both public and private events.
- All students are expected to conduct themselves in accordance with the [Ten Ethical Principles](#) at all times.
- Display of profanity, temper, flagrant violation of rules, etc., will not be tolerated. Individual behavior during a band function is a reflection of the group.
- Students will follow directors' instructions and procedures at all times.
- Students will be in their assigned rehearsal area ready to work at the set rehearsal time with all equipment, including music, pencil, instrument, and all supplies to rehearsals daily.
- Students will keep hands, feet, and other objects to themselves.
- Students will not use or play on equipment they do not own without permission from a director.
- Students will not touch, handle, borrow, or use anyone else's instrument, uniform, or personal belongings.
- Students should request permission to speak by raising your hand and waiting to be acknowledged.
- All rehearsals are expected to be silent so that our time will be utilized wisely and as efficiently as possible.
- When allowed in the band hall, either before or after school, students will not disturb any rehearsal in progress.
- Students will respect the property of others and return their equipment to its proper storage place when not in use. Students should keep their equipment in the designated storage area and keep said storage area clean and neat in appearance. Students who demonstrate great difficulty with this may lose the privilege of having a storage area in the band hall.
- Students will not deface or mark on music stands, chairs, walls, etc.
- Students will not write on dry-erase boards without permission from a director.

- Students will utilize their assigned storage slot/locker for instrument cases during rehearsals. Cases should not be brought into rehearsals unless requested by a director.
- Students will refrain from correcting fellow students in a pedagogical manner. The directive for any band member is to be the best possible individual performer as possible, and all energy should be directed in their personal performance and preparation.

Digital Citizenship

Maintaining a higher standard of conduct will also include ensuring that band member websites and communication on social media are appropriate. The internet is a worldwide, publicly accessible form of communication. Any communication appearing on the internet is public domain, even if it is marked private. Students are responsible for their online presence in all forms of digital communication and social media. Additionally, students may not create any website or social media group that implies a connection to or appears to represent an LISD organization. The areas of inappropriateness include but are not limited to profane, foul, or disrespectful language (abbreviated or alluding to), pictures, suggestive poses, clothing, references to alcohol, drugs, and/or tobacco, and postings (either verbal or photos) that could be interpreted as being negative or threatening towards other LISD teaching staff or band members, or that demonstrate poor sportsmanship or a disrespectful attitude towards other bands. Any such incident will result in review by the principal (or designee) and may lead to probation or dismissal from the band. Students should also be aware that accounts that they follow may inadvertently associate them with objectionable material.

Band members that violate the above internet guidelines shall be subject to the following:

- Upon confirmation of a violation, the member will be directed to remove any offensive items from the website(s) and to collaborate with the director to provide an action plan to deter future instances of similar behavior, which will be presented to the principal, directors, and band members. Items in the action plan may include but are not limited to an apology to the band and directors, training in the proper use of social media, or other actions deemed appropriate by directors or campus administration. Parents/guardians will be contacted and made aware of the offensive behavior.
- If a violation occurs that is deemed to be of a more serious nature, including but not limited to a threat, bullying, inappropriate and/or foul language, or a series of violations, the student may be subject to a higher level of discipline as determined by the director and school administration, such as suspension, probation, or dismissal from the band.

Sexual Harassment

Inappropriate verbal or physical conduct of a sexual nature at school is prohibited by school board policy. Sexual harassment is prohibited against members of the same sex as well as against members of the opposite sex. Any student who experiences a sexually offensive comment or action by another student or adult at school or school-sponsored function is strongly encouraged to tell a parent, teacher, counselor, or principal. Parents/guardians who have reason to believe that their child has been subjected to sexual harassment should report this behavior to the principal. If a violation occurs, the student may be subject to a higher level of discipline as determined by the director and school administration, such as suspension, probation, or dismissal from the band.

Due Process

All Leander ISD students are entitled to due process in accordance with LISD guidelines. Our goal as a staff is to ensure that all students are treated fairly. Please contact one of the directors if you have any concerns. We will work with you to resolve problems. We are here to provide a quality music education for all our students.

Financial Obligations

It is the philosophy of the Rouse High School Band that no student should be denied the privilege of band membership due to financial hardship. For options in meeting financial obligations, parents should contact the Director of Bands.

Band Fee

All Rouse Band members will be responsible for this annual fee. The purpose of the fee is to help with the various expenses that are necessary to run a quality band program that are not fully covered by the school district. These include but are not limited to such items as clinician services, contest entry fees, printing specialty items, general supplies, marching band design coordination, charter bus rentals, social activities, and more as voted on by the Band Boosters.

Hospitality Fee

This fee is part of the overall band fee and covers all pre-game meals, specified meals at camps and some contests during the Fall Marching Season.

Uniform Cleaning

This fee is part of the overall band fee. All concert uniforms are professionally cleaned at the same time. All marching uniforms are cleaned and are maintained by parent/student volunteers. Other costs include alterations, repair, and sundries associated with maintenance.

Misc. Supplies

This fee is part of the overall band fee - includes, but not limited to, various supplies such as lyres, flip folders, and raincoats.

Assessed Fee/Student Apparel

Fees listed below are approximate and may vary from student to student. *Assessed fees are NON-REFUNDABLE once the order for these items has been placed.*

- **Marching Shoes:** This is a required item that must be purchased through the band. All marching band students must have the approved black marching band shoes. No other shoe will be acceptable. (40)
- **Show Shirt:** This shirt is optional for all marching members and families. (20)

- **Band Shirt and Shorts:** These are required items that must be purchased through the band. Casual uniform, worn at pep-rallies, informal concerts/events, and underneath the uniform for games and contests. It is recommended that students have 2 sets of these since they will be frequently worn twice in one week. (25 per set)
- **Duffle Bag:** This optional item is recommended as it will allow to student to safely carry the many items they must take care of and keep with them on game and contest days. (35)
- **Water Jug:** This is a required item that must be purchased through the band. All marching band students must have the same cooler for uniformity. Sharing water is not allowed for health reasons. (15)

Equipment Fee - \$62.50 per semester

This fee is for students with district-owned instruments and all percussionists. This fee is to offset the cost of chemical cleaning and minor repairs for the end of the school year. For percussionists, this fee helps offset the cost of heads and mallets. This fee does not cover damage due to negligence (accident or otherwise).

Winter Guard

Winter Guard begins at the conclusion of the Marching Band Season. Expenses may vary from year to year, but winter guard fees are typically between \$400-500. These fees are included at registration fee assessment, and payments are spread over multiple months. Overnight competition trips are an additional fee for travel - this amount will be communicated to families in November/December once travel arrangements are set. These competitions are TBD per season.

Spring Trip

The concert bands and/or color guard may take a trip in the spring. A Texas beach trip will be the in-state trip on in-state trip years. (Varies)

Fee Refunds

Band fees will be paid at May registration and throughout the summer for the following year. Students who choose to leave the program after July 20th, 2020 will not be eligible for a refund of any paid band fees. **Apparel fees will be non-refundable after the order has been sent in (typically mid-late June).**

Fundraising

The Rouse High School Band and Band Booster Club engage in fundraising activities throughout each year. The funds raised from fundraising activities will be credited to an account held by the Booster Club and are subject to all state laws. This money will be used only for the direct benefit of the band program and its students and staff.

Care of the Band Facilities

- Food and Drink – No gum, food or drinks are allowed in the building except when authorized by the directors. The Rouse High School Band Hall is a water only facility.
- Litter – All trash (paper, broken reeds/drum sticks, etc.) is to be deposited in the wastebaskets provided.
- Vandalism – Acts of vandalism or the willful misuse of school property will be dealt with severely and appropriately. Every band member is responsible to help the directors monitor the facility and control vandalism, which includes writing or carving on walls, destroying music, or breaking school property.
- Workroom – Absolutely no student is allowed in the workroom without permission. The copy machine is off limits without permission.
- Practice and Ensemble Room Guidelines - These facilities are for practice only. Practice rooms should be limited to two people at a time unless special permission is granted.
- Band Offices – Band offices are off limits to students. Students must knock and/or be given permission to enter.

Attendance/Punctuality

In order to have and maintain a high-quality band program, attendance from all members is essential. While the RHS band follows all school and district policies and procedures, the following additional guidelines outline the attendance procedures and policies for the RHS band. These attendance guidelines also apply to activities held outside of the school day. Grades are given for punctuality and attendance. Additionally, consequences and interventions related to attendance and punctuality are outlined on the [Handbook Acknowledgement Signature Page](#).

Attendance

- Members are expected to attend all rehearsals and performances. This includes outside of school rehearsals, class rehearsals, sectionals, masterclasses, clinics, pep rallies, concerts, contests, and/or meetings.
- Families should avoid scheduling appointments at the same time as rehearsals and performances. Refer to the [Rouse Band Calendar](#) for scheduled rehearsal and performance dates/times.
- Excusal from any rehearsal for performance must be approved through the Rouse Band absence request form on the Rouse Band Website. **Absences must be requested at least 1 week in advance if they are not due to illness.**

Punctuality

- For all events, “On time” within the Rouse Band Organization and Program is defined as:
 - Arriving with enough time to store personal items, gather materials, retrieve & set up instrument(s), and prepare mentally for rehearsal/performance; AND,
 - Being set with all instruments, equipment, supplies, and music ready to play no later than 10 minutes before the official start time of rehearsal.

Absences and Tardies related to Academic Tutorials

Students are afforded a daily academic tutorial advisory period (Advocate) and before school opportunities which do not conflict with normally scheduled marching band rehearsals, therefore missing before or after school rehearsal for the purposes of tutorials or make-up work will be considered unexcused. A major percentage of each student's grade is counted toward before and after school co-curricular rehearsals. The Rouse Band Staff will be monitoring student attendance and student's grades will reflect accordingly.

Tardiness

Students not in their designated area at the appropriate time will be marked tardy. A tardy will be converted to a mark of absent 15 minutes after the rehearsal begins.

Unexcused Tardiness

Unexcused tardies will be subject to the consequences and interventions listed on the Handbook Acknowledgement Signature Page.

Unexcused Absence

Students not present at the appropriate time without appropriate communication will be marked absent. Unexcused absences will be subject to the consequences and interventions listed on the Handbook Acknowledgement Signature Page.

Excused Absences

Absence due to personal illness requiring medical attention, death in the family, or other extenuating circumstances (approved by the director) may be considered for excused status. Students who are continually ill may be required to provide a doctor's note releasing them from participation in order to ensure the well-being of the child and to reduce concerns of the band directors. **Excessive absences of any kind (excused or unexcused) from class or rehearsals outside of the school day will result in loss of varsity status and/or removal from performance opportunities.**

Daily Supplies

The following list is what each student should plan to bring to the appropriate rehearsal and/or performance. Other items may be added:

- All issued music in an organized binder
- Pencil
- Instrument
- Tuner and Clip
- Breather
- All supplies relative to their instrument
- All marching related equipment (during marching season)
 - UDB app on a charged phone (may bring portable chargers)

- Lyre/folder
- Rouse Water Jug
- Other marching equipment as needed (could vary from year to year).

In addition, a metronome and tuner should be part of a band member's tools for home practice.

Missing supplies will result in grade reductions on the Weekly Participation Sheet. Habitual loss or lack of having these necessary supplies will be subject to the interventions and consequences outlined on the Handbook Acknowledgement Signature Page.

Approved instruments (for non school-owned instruments) and mouthpiece/ligature setups can be found [here](#). In addition, the following list for each instrument consists of preferred or highly recommended supplies. Any deviance from this list should be approved by a director. Private lesson teachers may make recommendations that stray from this list after consulting with an RHS band director.

Flutes

- Tuning and cleaning rods
- Cleaning cloth
- Key oil
- Screwdriver Set

Clarinets

- Three good playable reeds. Vandoren Blue Box, and V-12's are the approved reeds.
- Reed guard (plastic, with rubber bands to hold reed in the guard are preferred)
- Key oil (Case Storage)
- Bore oil (Home Storage)
- Cleaning swab (silk handkerchief style, with covered weight)
- Cork grease

Saxes /Bass Clarinet as applicable

- Three good playable reeds. Vandoren is the approved reed.
- Reed guard
- Neck Strap (Bass Clarinet players included)
- Pad and neck saver

Trumpet

- Valve oil (Al Cass)
- Polishing cloth

French Horn

- Valve/Rotary oil - (Al Cass - Marching Horn) (Holton Rotary - Concert Horn)

- Polishing cloth

Trombone

- Slide cream
- Spray Water Bottle
- Polishing Cloth

Baritone/Euphonium

- Valve oil (Al Cass)
- Polishing cloth

Tuba

- Valve/Rotary oil - (Al Cass –Sousa Valves /Holton – Concert Rotors)
- Polishing cloth

Percussion

- Stick/Mallet bag
- Practice pad

Color Guard

- Flag pole, including accessories (provided by the district)
- Rifle (if applicable, provided by the district)
- Sabre (if applicable, provided by the district)
- Electrical Tape
- Gloves

District-Owned Instruments

LISD will provide a limited number of instruments for student use. These instruments include highly expensive instruments such as the bassoon, oboe, tenor saxophone, baritone saxophone, french horn, euphonium, tuba, and general percussion equipment. This equipment is generally purchased by the school district for student use because of its extremely high expense. Thus, **all district owned equipment must be handled with optimum care.** Students failing to take proper care of their school-issued instrument may lose the privilege to use such instruments.

The following is a list of general procedures for district-owned instruments:

- LISD does not provide insurance for individually owned or district-owned equipment. It is required of all students utilizing district-owned instruments to provide insurance coverage for the instrument that has been issued to them. Students will be held responsible for all district-owned instruments

issued to them. This responsibility will include fire, theft, accidental damage, abuse and general maintenance not incurred through normal use.

- Students and parents must sign an instrument checkout form before the student can use the instrument.
- Each instrument will be issued in good playing condition. Each issued instrument will be checked and cleaned prior to issue. Students are expected to maintain their issued instruments accordingly.
- The band member is financially responsible for all equipment and/or materials checked out to him or her.
- All equipment and materials must be kept in their proper storage location when not in use.
- LISD will assess a fee for routine (end of year) cleaning and maintenance of district-owned instruments. This fee will be collected at the beginning of each school year, by the Rouse Band Boosters, and then forwarded to LISD.
 - a. NOTE: this fee does not cover removal of dents or other student-responsible repairs
 - i. Any repair needed due to student negligence will be assessed at the time of repair, payable to the Rouse Band Booster Organization.

Special Note

District-owned instruments are not to be treated as "free" instruments. Basic supplies must still be purchased, and repairs must still be made just like personally owned instruments. Please strive to treat these instruments as if they were your own. All LISD-owned instruments exceed \$2,000 in value.

Grading Guidelines

LISD band programs have instructional objectives that relate to the mandated Texas Essential Knowledge and Skills (TEKS) for grade level subjects or courses. These objectives are aligned to address the academic skills needed for successful performance in the next grade or next course in a sequence of courses. Assignments, tests, projects, classroom activities, and other instructional activities are designed so that the student's performance indicates the level of mastery of the instructional objectives. The student's mastery level of these objectives is a major factor in determining the grade for a subject or course.

Students will be expected to meet the responsibilities for each band class as determined by the director. Since band is an academic music class with some extra-curricular activities attached, the band student's grade will reflect achievement in both curricular and extracurricular areas.

A band member's six weeks' grade will be determined from the following items: students' daily preparation and participation, individual testing, performances, and extended classroom activities such as sectionals and before/after school rehearsals. For more specific information, pertaining to how a student's grade is determined, please consult the director.

The following list is provided to give students and parents examples of items that can be subject to grading. Additional assignments may be given any time.

Participation

- Weekly Participation Sheet - tracks materials

- Smart Music Assignments - rehearsal preparation and skill development
- Practice Records - at home practice and accountability

Assessments

- Performances/Games - attendance and successful participation
 - See “Performance/Rehearsal Requirements” section for all stipulations to earn full credit
- Pass-offs/Performing Test - graded playing/performing assignments which could be live or recorded and submitted Google classroom (or similar)

Co-Curricular Rehearsals

- Sectionals - attended on time and prepared
- Masterclasses - attended on time and prepared
- Rehearsals - attended on time and prepared
- Any type of required, outside-of-the-normal-school-day rehearsal

Eligibility

All LISD Bands adhere to the eligibility rules and regulations as stated by TEA and LISD. Some band activities are designated as extra-curricular. Students participating in these activities are governed by eligibility requirements. A student shall be suspended from participation in all extra-curricular activities sponsored or sanctioned by the school district during the six-week period following a grade reporting period in which the student received a grade lower than seventy in any class. Loss of eligibility does not take effect until seven days after the end of the reporting period. Ineligible students are not suspended from practice or rehearsal of extra-curricular activities. The student is not suspended from participation during the period in which school is recessed for the summer or any other vacation time.

Students may regain eligibility under certain circumstances. If a student has been suspended as a result of failing, he/she may regain eligibility by passing ALL courses in the third week of the affected grading period. Reinstatement of eligibility would occur seven days after the three-week progress report period (see TEA/UIIL Side by Side).

Activities that are considered curricular components of any course are not affected by the eligibility law. Examples of these activities are all rehearsals and performances that take place as a regular extension of classroom instruction. Any performance that is competitive in nature or for which admission is charged is deemed extra-curricular.

Academic Expectations

All Rouse Band Students are expected to maintain continuous positive academic standing at Rouse High School.

Positive academic standing is defined as:

- Grades of 70 or higher at all times in all classes
- Completing and turning all assignments on time to all classes (including band)
- Communicating with band staff and academic teachers immediately when the above requirements are not met

Students who fail to meet the above academic standards/expectations after the first three weeks of school are subject to the consequences below:

- Attend mandatory tutorials outside of band rehearsal times (morning and/or advocate)
- Probationary status
 - Suspension from performance and/or contest participation (marching or concert)
- Removal from Varsity Marching Band placement and reassignment to JV

Students who fail to meet the above academic standards/expectations by receiving a grade lower than 70 on a report card are subject to the consequences below:

- Attend mandatory tutorials outside of band rehearsal times (morning and/or advocate)
- Probationary status
 - Suspension from performance and/or contest participation (marching or concert)
- Re-assignment to a lower concert ensemble
- Removal from Varsity Marching Band placement
- Removal from Rouse Band Spring Trip
 - Student may not be eligible for refund of trip payments if contract deadlines have passed, resulting in potential financial loss
- Limitation of future concert and marching band placements and/or re-assignment to a lower ensemble, including JV status during marching band.

Travel Guidelines

The band will frequently travel on either school buses or commercial buses. Student conduct is expected to be at the highest level on any trip.

- Students must travel to events and return from events on the bus. Any student wishing to arrive or leave with his/her parents must notify a director in writing with parent signature, prior to the event. Permission will be granted or denied based on the circumstances of the occasion.
- Students must have all necessary forms (Medical/Travel Release) completed and on file with the band office to travel on any trip with the band.

While on the bus students will:

- Remain seated at all times.
- Sit properly in a forward position.
- Keep the bus clear of food, drinks, and debris (At times it may be necessary to eat a pre-game dinner on the bus. Every effort should be made to keep your area clean).

- Keep all body parts inside the bus.
- Use headphones (no speakers).
- Remain silent when addressed by the person in charge on the bus.
- Refrain from loud, boisterous talking, singing, screaming, whistling, inappropriate jokes, etc.
- Refrain from public displays of affection.
- Remain silent from the time they step onto the bus until otherwise instructed.
- Follow all instructions of chaperones and bus captains.

Special Note:

Students are reminded that all performances start and conclude at the band hall. As a member of the band, you are a representative of your school. Always be on your best behavior. If you are in doubt about an action, do not do it! Your conduct at all times should be considered a good reflection on the school, the band, your home, yourself, and the community.

Chaperones

Adult chaperones are a great asset for the band program. Students will treat them as an extension of the band staff. Proper respect will be shown to all adults at all times.

Spring Trip

The band may take an out-of-state trip every other year. Examples of previous trips include New York, L.A, Orlando, and Colorado. In years when the band is not going out-of-state, they may travel to an in-state location such as Dallas, San Antonio, Houston, or Corpus Christi.

Auditions and Ensemble Placement

All audition results and resulting placements are based on collected data from student's regular participation which includes but is not limited to:

- Completion of regularly assigned coursework (pass-offs) in band class (punctuality matters and is considered as part of the criteria)
- Marching season participation (attendance, preparation, commitment)
- Consistent preparation and participation in All-Region/All-State hearings and master classes
- Consistent preparation and participation in instrument choir/ensemble rehearsals and performances
- Consistent preparation and participation concert band rehearsals
- Consistent preparation and participation in YAC preparation and performance processes
- Attendance at preparatory camps leading to auditions
- Positive academic standing, defined as **continuous** maintenance of at least a "C" average in all classes
- Leadership appointments

Other guidelines:

- Students are required to audition for participation in the Rouse band
- Directors will serve as an evaluator during auditions
- Auditions may be live or recorded at the director's discretion
- Students who must opt for a single block band schedule will be placed one band lower than current skill level
- Single block option is at the discretion of the Director of Bands

Concert Ensembles

Honor Band and Wind Ensemble

Selection into these groups is by audition, director recommendation, and demonstration of academic proficiency. Members of the Honor Band will participate in the TMEA Region Band process, and members of the Wind Ensemble will prepare region music with the goal of participation. Members of both ensembles will also participate in UIL Marching Contest (varsity status only), Rouse Young Artist Contest (required), and UIL Concert and Sight-reading Contest (contingent on successful pass-off completion). Members of this group will have a 90-minute section rehearsal, an assigned hearing time outside of the school day, and weekly SmartMusic assignments. Both ensembles will give numerous performances both on and off campus. In UIL activities, these groups will be designated as the "Varsity" and "Non-Varsity" band.

Symphonic Band

Selection into this group is by audition. This group will participate in UIL Marching Contest (varsity status only), Rouse Young Artist Contest (required), and UIL Concert and Sight-reading Contest (contingent upon successful pass-off completion). Members of the Symphonic Band will participate in the TMEA Region Band process by invitation. Members of this group will have a 90-minute section rehearsal, an assigned hearing time outside of the school, and weekly SmartMusic assignments. This group will give a variety of performances. In UIL activities, this group will be designated as the "Sub-Non-Varsity" band.

Concert Band

Selection into this group is by audition. This group, at varying levels, will participate in UIL Marching Contest (varsity status only), Rouse Young Artist Contest (required), and UIL Concert and Sight-reading Contest (contingent upon successful pass-off completion). Members of this group will have a weekly Smart Music assignment. This group will give a variety of performances. In UIL activities, these groups will be designated as the "Sub-Non-Varsity B" band.

Members of any Rouse performing ensemble (including those not listed within this section) will:

- Successfully complete the audition requirements by the appropriate time
- Demonstrate high quality performance skills in line with the expectations of the ensemble
- Adhere to attendance and punctuality standards
- Have all necessary supplies for all rehearsals and performances
- Be prepared for rehearsals by completing practice assignments such as Smart Music or those
 - outlined on the Practice Record

- Maintain continuous positive academic standing at Rouse High School:
 - Grades of 70 or higher at all times in all classes
 - Completing and turning all assignments on time to all classes (including band)
 - Communicating with band staff and academic teachers immediately when the above requirements are not met
- Represent the school, school district, band program and themselves with the highest possible decorum and behavioral standards.

Special Note:

Non-compliance with the above guidelines are subject to the interventions and consequences outlined on the Handbook Acknowledgement Signature Page.

Performance Requirements for Concert Ensembles

Each of the concert ensembles will perform at various times throughout the school year. Students are expected to participate in the performances of their assigned ensemble.

Performances of the concert ensembles will include but are not limited to the following:

- Fall Concert and Marching Band Performances
- Winter Concert
- Midwinter Concert (Instrument choirs for Honor Band & Wind Ensemble students [top two bands])
- Spring Concert
- Band Festivals/Pre-UIL Contest
- UIL Contest
- Spring Trip Festival
- Honor Band Recording Concerts (Honor Band students only)
- Others as needed

Concerts/Performances

Concerts and performances are an integral component of the band curriculum. Families should consult the band calendar for dates and times. Periodically, the schedule may change, and updates will be communicated. Concerts are considered to have three parts: warm-up, performance, and listening. The concert begins for the student at the warm-up. Punctuality is essential. A concert concludes after the last group performs and directors have given permission for students to be dismissed. A general report time will be given for all students.

- All concerts are a group effort; thus, attendance is ***required***.
- All concerts are an extension of the classroom and will be graded accordingly.
- Students should be punctual and prepared for each performance/concert.
- In the event a performance causes a student to miss another class, the student is responsible to make up all missed work!
- The appropriate dress for all concerts will be a dress uniform (see Uniforms).
- Students are expected to stay the entire concert.

- Students are expected to help move equipment and reset facilities at the end of performances as requested by the band staff.

Private Lesson Program

This is a district wide program that provides a high-quality enhancement to classroom instruction. Teachers are all specialists on their instruments. All of our teachers are professional musicians in the Austin area and have advanced degrees in the performance of their instruments. Lessons are extremely valuable to the individual student and are highly encouraged.

- *ALL* students are *ENCOURAGED* to take individualized private instruction.
- Teachers are vetted by the band staff in addition to being cleared by the district.
- Lessons will be given weekly during the band classes or before or after school.
- Detailed information will be distributed on the private lesson program.
- Enrollment in the Rouse Private Lesson program is a *year long commitment*.
- During testing weeks or breaks, lessons can be arranged via Zoom (or similar) at your discretion.

Marching Band

Background Information

Leander ISD has enjoyed a reputation for excellence in music performance, including marching band, for many years. The marching band is the most visible aspect of the band program. The marching band provides performance opportunities for band students while integrating the band program into school and community activities.

Marching Band Participation

As an integral part of the band program, Leander ISD's philosophy is that educationally, historically, and musically, marching band is an essential ingredient in a well-rounded music education in band. LISD believes that music students need to develop the ability to participate and perform in different ensemble experiences which, for band students, includes the marching band. As a result, marching band is required for all high school students who elect to take an academic band performance course. However, students who have medical complications or physical disabilities may be excused from participation at the discretion of the head band director. Philosophy regarding all aspects of high school band stems from TEA/UIIL guidelines which govern all Texas schools.

Physical Education Requirement Credit

As an artistic endeavor, each rehearsal and performance by the marching band is mentally and physically demanding. For the full marching band performance, students are always on task and must bring to the experience their best performance skills. As a result, each student in the marching band is eligible to receive a physical education substitution credit (maximum 1 credit) in accordance with TEA guidelines.

Marching Band an Integral Component of State Curriculum Requirements

The music and performance skills and techniques, along with the associated academic skills in the band program, are derived from implementation of the expectations found in the Texas Essential Knowledge and Skills (TEKS). The curriculum specifically includes requirements such as demonstrating musical skills and artistry, performing in different musical mediums, and experiencing music through a wider range of music literature, which are addressed through the marching band. Each performance by the marching band provides students the opportunity to demonstrate musical artistry through the ensemble, individual music performance skills and techniques, marching performance skills and techniques, and critical thinking skills that include auditory, spatial, and visual awareness.

High Academic Standards Maintained by Students

The opportunity for weekly performance is a motivating factor for academic achievement for marching band students, since only by maintaining their eligibility can they continue to perform. As a result, the directors have documented the fact that the least number of ineligible band students during the year occurs during the marching season.

Color Guard

Students in Color Guard are a part of a year-round program and participate in all activities, including the Fall Marching Band (Visual Ensemble) and Winter Guard season. Band students in Color Guard must be enrolled in the Color Guard elective class and must maintain all academic and extra-curricular responsibilities. Students not in band may audition for and participate in Color Guard with the approval of the Head Band Director and Color Guard Director. Students who quit band are not allowed to rejoin as Color Guard members. As members of the marching band, Color Guard students receive a physical education waiver.

Grading

Since marching band is a part of the academic band course and therefore, part of the graded curriculum, students in marching band are responsible for assimilating the academic aspects of the band elective as found in the Texas Essential Knowledge and Skills (TEKS). Attendance at rehearsals and performances is mandatory and will be integrated into the student's grade for band in accordance with TEA/UIIL guidelines.

Practice Time Limits

Marching band practice times are regulated by TEA/UIIL guidelines. Adherence to these guidelines is the responsibility of the Head Band Director at each high school. As per TEA and UIL rules: "The members of a marching band or any of its components may not begin the marching preparation for a UIL contest presentation prior to August 1. In addition, no more than ten hours of director-supervised instructional time may be devoted to marching fundamentals between the end of the previous school term and August 1." Music preparation is not affected by this ten-hour rule. Between August 1 and the 1st day of school, practice schedules are determined by the Head Band Director. During the school year, no more than 8 hours of rehearsal per week, outside of the school day, is allowed. Exceptions to the 8-hour rule include preparation immediately before games and competitions. LISD observes all of these guidelines.

Rehearsal and Performance Schedules

Rehearsal and performance schedules are determined by each band staff and are published on the band's calendar found on the band website.

Instruments

Marching band students who play an instrument that the LISD does not provide (flute, clarinet, alto sax, trumpet and trombone) must personally provide, march and perform with the same instrument they use in band or a second instrument of the same type that is approved by the Head Band Director.

Leander ISD assumes no responsibility for maintaining instruments they do not supply. Since these instruments will be played outside in various weather situations (sun, heat, wind, rain, etc.) students and parents need to be vigilant regarding instrument maintenance to keep the student's instrument in top playing condition.

Marching Band Positions

Varsity (Primary) and JV (Alternate) positions for the Marching Band will not be determined until after the first week of summer band camp at the end of July and will be assessed based on the following:

- Summer pass-off participation
- Summer pass-off achievement
- Summer band camp participation (attendance/punctuality)
- Overall marching and playing skill/coordination
- Performer viability

Varsity/Primary Marchers

In order to maintain varsity/primary status, such students must:

- Successfully complete all band assignments on time
- Maintain demonstration of high-quality marching and playing skills
- Adhere to attendance and punctuality standards
- Be prepared for rehearsals by completing practice assignments such as Smart Music or those outlined on the Practice Record
- Maintain continuous positive academic standing at Rouse High School:
 - Grades of 70 or higher at all times in all classes
 - Completing and turning all assignments on time to all classes (including band)
 - Communicating with band staff and academic teachers immediately when the above requirements are not met
- Represent the school, school district, band program and themselves with the highest possible decorum and behavioral standards

Special Note:

Non-compliance with the above guidelines are subject to the interventions and consequences outlined on the Handbook Acknowledgement Signature Page.

JV/Alternate Marchers

The band directors will keep the number of JV/Alternate Marchers to a minimum; however, they are a necessary and vital aspect of our program due to the UIL “No Pass/No Play” rules and to prepare for possible substitutions due to injury, sustained illness, etc. JV/Alternate Marchers will meet the same attendance, rehearsal, memorization, academic, and performance requirements of primary marchers. Specific drill may be written, and music may be edited for those students who are not yet able to achieve the physical and musical demands required of varsity/primary marchers. This will help improve their individual skill level and will prepare them for future performance opportunities. As a band staff, we are committed to providing performance opportunities for all students, however the level of performance participation may be limited by eligibility and individual performance ability.

These JV/Secondary Marchers will be created for all sections: Winds, Percussion, and Visual Ensemble.

There are many ingredients that are vital to a successful marching program and no one part is more valuable than any other. Examples of ways that students can contribute to the performance are: Marching Winds, Marching Percussion, Pit Percussion, Visual Ensemble, Stage Crew, Pit Crew, and Tech Crew.

Football Game Procedures

The football game is viewed as a performance of the band program. Such performances include all aspects of the game from arrival to departure.

- Students will remain on campus after school on game days for a brief rehearsal and then for food provided by the boosters through the yearly meal fee paid by each family. This is in consideration of time, organization, and safety. Please do not ask for exceptions to this except in the case of food allergy.
- Students will arrive at the designated report time. For typical game days, this is defined as directly after school.
- Students will load and be prepared to travel at the designated load time.
- Students will load the buses with all equipment needed for the performance. The section leaders will inspect all students boarding buses prior to departure. Students not meeting uniform, music, and loading guidelines may be sent home and not allowed to participate. Students will receive an unexcused absence for such occurrences. Missing items or non-adherence to these guidelines can also result in a lowered grade for the football game performance.
- Upon arrival at the performance area, students will don all uniform components and prepare equipment for unloading. Students will unload buses when instructed to do so by a student leader, chaperone, or director. Exit the bus in proper uniform as instructed by the directors, carrying all necessary equipment in a garment bag unless instructed otherwise.
- Instruments that arrived via the equipment truck/trailer will be picked up at the designated area when instructed. All cases must be put back in the original location with latches closed.
- Students will report to the entrance formation for final inspection. Upon instruction from a Drum Major or director, students will walk into the stands in an organized fashion.
- Upon arrival to the seating area, students will remain standing until all band members have arrived and are prepared to be seated. Students will sit when instructed by a Drum Major or director. Students

will sit in the assigned seat and section. Students will remain in that seat and section at all times. Any movement in this bleacher adds risk to the safety of students and their instruments.

- Visual Ensemble members will have specific instructions on changing into and out of football and performance uniforms, at the discretion of the Visual Ensemble/Color Guard Director.
- Restroom breaks may be granted by a director, chaperone, or selected student leader. Every effort will be made to accommodate needs without jeopardizing the integrity of the section. Restroom breaks will not be granted in the second quarter of a football game.
- Students will be expected to listen for and watch the directors and drum majors during the game. Students will need to be prepared to perform at all times and at a moment's notice.
- Students will refrain from playing their instruments on an individual basis. The band will perform as a group or with approved small ensembles. While playing, always pay attention to the director/drum major.
- At the appropriate time, the band will be dismissed from the stands for the half-time performance. At this time, the band must move quickly, quietly, and efficiently to the appropriate area. Students will need to be focused on the directors' and Drum Majors' instructions.
- At the conclusion of the half-time performance, students will return to the stands and continue in the stand performance throughout the remainder of the game.
- During the 3rd quarter, we will participate in the good sportsmanship procedures of officer meetings and introductions. The VP of Events will create a schedule of which student members participate in this event each week.
- At the conclusion of the game, students will load busses quickly and efficiently.
- Upon return to the band hall, students will ensure that all personal items, uniforms and instruments are placed in the proper storage areas.
- At the conclusion of each engagement, there may be a brief meeting, including watching a video of our performance from that game, before dismissal. Students are not required to stay for the video.

Marching Band Performance Procedures

- **Report Time:** This will be the designated time at which all members should be at the high school or set location. Students should have all attire and necessary items for the designated performance prior to the report time.
- **Load Time:** This will be the designated time at which all members should be on the appropriate bus with all equipment loaded. All equipment will be checked by the section leaders. Students without appropriate equipment will be sent home and an unexcused absence recorded.
- **Return Time:** This will be the approximate time of return to the band hall.

What to bring:

- Garment Bag
- Black Shoes
- Black Socks
- Water Bottle
- Flip Folder (if game, pep rally, community event, or parade)
- Lyre (if game, pep rally, community event, or parade)
- Instrument with accessories

- Band Shirt
- Rain Coat
- Uniform Apparel
- Proper undergarments
- Hair Accessories (Hair spray, gel, bobby pins)

Pre-performance Practice:

- Wear black shoes, black socks, band shirt
- No fingernail polish
- No jewelry
- Bring all equipment (weather permitting): that means **everything** (drums, uniforms, etc.)

Music Inspection

Music inspection will occur before all football games and marching band performances that will utilize music which is not part of the field/competition show. Students will be asked to display music, lyre (if appropriate), and flip folder. Students who do not pass music inspection may not be allowed to perform.

Uniform Inspection

Prior to student departure for a marching band performance, students must pass a uniform inspection. In order to board the bus, students must have a complete uniform, raincoat/poncho, music, flip folder, and other components for the marching performance. Students who do not pass the uniform inspection may not be allowed to attend the event. Students not meeting uniform, music, and loading guidelines will be subject to disciplinary consequences and grade reductions.

Visual Ensemble members will also go through a uniform inspection, including rehearsal/summer uniform, competition uniform, and all equipment. VE Lieutenants will complete this inspection before loading the truck or bus.

Instrument Loading/Unloading

Large instruments will be transported on the band trailer/instrument trucks. All others (flutes & clarinets) will transport their instruments on the bus. Students will be responsible for ensuring that their instrument or empty case is in the proper location. After the instrument truck/band trailer has been unloaded, each student will be responsible for picking up their instrument and storing it correctly. Students who display difficulty in following the loading and unloading procedures may lose the privilege of utilizing the instrument truck.

Loading Procedures

The VPs of Logistics will designate the appropriate area for all instruments. Students should ensure that their instrument is in the proper place. Cases should be latched and secure. Instruments in the wrong area may be overlooked and not loaded.

Unloading Procedures

The VPs of Logistics will designate the unloading area. Students should uncase their instrument and leave cases in the appropriate area. Unloading should be done in a timely and efficient manner.

- All instruments except clarinets and flutes will be expected to transport instruments on the band trailer/instrument truck.
- Case should be closed and secure. Instruments in the wrong area may be overlooked and not loaded.
- Students will be responsible for seeing that their instrument or empty case is in the proper location.
- Section leaders will complete inspection/pass-off and lead their section to the cafeteria (once complete).

Arrival at RHS:

- Students will also be responsible to see that their instrument is picked up and stored correctly upon the unloading of the instrument truck.
- Return uniform (hung properly) to the designated uniform rack.
- Once the truck is completely unloaded and everything is put away, a video of the performance will be shown in the Band Hall. Students are not required to stay for the video.
- Students who display difficulty in following the loading and unloading procedures may lose the privilege of utilizing the instrument truck.

Uniform Guidelines

Students are expected to follow the listed uniform guidelines. No variations will be allowed.

General

- Marching Band uniforms will be issued during summer band camp. Band uniforms will be stored at school in the uniform storage area.
- Concert Uniforms will be issued in November. Concert uniforms will be stored at school in the uniform storage area. Boys will be responsible for their own shoes, prescribed tuxedo shirt (wingtip collar, pleats, no ruffles), studs and cufflinks (optional).
- Band parents will perform the initial uniform alterations if needed.
- Students will be held financially responsible for the uniform(s) and all components.

Uniform Guidelines

- Always wear and treat your uniform with pride. The uniform should be worn as a complete unit at all times when in public. The only exception to this will be when a director instructs you that you may remove your hat or coat. Loading crews may be exempt from wearing the uniform during loading/unloading procedures. **Absolutely no running in uniform.**
- The Rouse Band tee-shirt is to be worn under your uniform. The band shirt will be part of pre-performance inspections
- You must wear approved black band shoes and long black socks (student purchases).

- Jewelry, hair ribbons, and nail polish etc. are unacceptable while in uniform. These items hinder the uniform appearance of the band
- Band students with long hair will need to put it up under their hat during performances. Hair must not touch the collar of the jacket and must be above the top of the ear or pulled behind it. No visible hair on forehead.
- **Only natural hair colors are allowed**
- No consumption of food and drinks (other than H2O) while in uniform without permission.
- Students not properly hanging the uniform will receive a community service assignment.
 - Keep the collar hooked and the jacket zipped while hanging to retain the shape of the coat.
 - Always hang the pants by the crease, careful to avoid wrinkles, and lock the dowel into the metal catch to keep the pants secure.

Color Guard/Visual Ensemble

- Personal appearance is crucial to the Visual Ensemble's role in performance. Students will be given a specific hair and makeup style to wear at football games and at competitions - this is to be strictly followed.
- Hair and makeup supplies are not provided by the band or district.
- **Only natural hair colors are allowed**
- Any changes in hairstyle (including color) should be approved by the Color Guard Director prior to making any change. This could affect the performances for both marching band and winter guard.
- Students should not have facial piercings (except for ears), unless they can be covered, nor visible tattoos in a traditional sleeveless costume.
- Only prescribed accessories that are part of the uniform may be worn.
- Students should not have any visible tattoos. If so, they must be covered with makeup or a bandage as not to be seen.

Color Guard/Visual Ensemble Uniforms

- Students are responsible for the care of their assigned uniform. Any damages should be reported to the Director and repaired as soon as possible.
- Laundering will be completed by a parent committee and organized by the Visual Ensemble VP of Uniforms.
- Students and families are given laundering instructions with their costume once delivered. Absolutely no change should be made to the proscribed laundering methods. If laundering is needed between provided treatment, please adhere to distributed instructions.
- Any cost for loss, damage or repair to a costume will be the student/family's responsibility.

Uniform Costs

If a uniform part is damaged or lost, the student will be responsible for the replacement costs. All marching uniforms are professionally cleaned at the same time to prevent unequal discoloration and fading. The costs for cleaning are collected from each student in advance (see Financial).

Color Guard Information

Dressing Out

Students must wear proper attire during any class, rehearsal or performance. Daily Class or Rehearsal Attire includes:

- **HOT WEATHER**
 - Shorts: appropriate length
 - Tank Top or T-Shirt: School appropriate, light-colored and breathable fabric
 - Sports bra (ladies)
 - Socks
 - Tennis shoes: tennis, running, cross training shoes are appropriate - no boots, sandals, Converse/Bobs/Toms/etc.
 - Hair pulled back, out of your face, in either a bun or a ponytail - NO BANGS (must be pinned, gelled, or held back with a headband).

- **COLD WEATHER**
 - Leggings/Sweatpants
 - Layers with long sleeves
 - Including appropriate jackets for temperature/weather
 - Sports bra (ladies)
 - Socks
 - Tennis shoes
 - Hair pulled back, out of your face, in either a bun or a ponytail - NO BANGS (must be pinned, gelled, or held back with a headband).

- **INDOOR:**
 - Black leggings or black spandex shorts with tights
 - SHORTS MUST BE WORN WITH TIGHTS FOR INDOOR REHEARSALS
 - Black tank top, t-shirt, leotard, etc.
 - Sports bra (ladies)
 - Students will not wear shoes (unless approved by the director), but may wear socks at their own discretion
 - Students may be asked to remove socks during dance class for safety.
 - Hair pulled back, out of your face, in either a bun or a ponytail - NO BANGS (must be pinned, gelled, or held back with a headband).

Duffle Bags/Guard Bags/Backpacks

Students should be responsible for bringing items they may need, individually, during the course of a rehearsal or show day. Some items are provided in a toolbox for team use, but students should have the following items handy at all times:

- White electrical tape
- Black electrical tape
- Bobby pins/hair clips

- Hair spray
- Hair ties
- DEODORANT/smell good spray
- Feminine products
- Kleenex/makeup wipes
- Show makeup and hair supplies
- Costume and/or rehearsal uniform parts (for warm up or football games)
- Extra socks
- Extra sunscreen

Winter Guard

Students in the Color Guard program participate year-round, which includes the fall Marching Band season and the Winter Guard program during the spring semester. Students will not be excused from one season for the other. Year-round participation is expected from all Color Guard members. Winter Guard rehearsal and competition dates are finalized and communicated during September and added to the Rouse Band and Rouse Guard calendars. There are traditionally Winter Guard Camps during the Winter Break holidays, but much care is taken for as full of a break as possible. Please consult the band calendar before making any holiday travel plans.

Rhythm Dance Company students and other Rouse High School students are eligible to audition for the Winter Guard Program on approval from the appropriate directors and Color Guard Director. Students are expected to maintain their academic and extra-curricular responsibilities to the highest level or participation in the Winter Guard will not be allowed. Band students are not allowed to join Winter Guard.

If joining the Winter Guard in the middle of the school year, students will be responsible for all member fees, meal fees and apparel fees upon joining.

Student Leadership

The high school band programs in Leander ISD provide many opportunities for students to develop their leadership skills with a variety of offerings. In this manner, students can not only serve their band program but also refine skills that they will be able to use in other school organizations, as well as in their future careers. Audition criteria is selected at the discretion of the directors and is communicated to the students. The directors evaluate all selected officer candidates based on their performance both during the audition and during their performance during the current school year.

Student leaders are held to higher standards of performance and behavior than a general band student. They are expected to be positive role models for all band members at all times. Please see Conduct/Expectation section pertaining to general conduct of students as well as student leadership positions.

Marching Band Student Leadership Positions

Drum Major(s)

The Drum Major(s) will be the conductor(s) for the marching ensemble. A Drum Major will serve the marching season for which he/she is selected. In the event that an underclassman is selected as Drum Major, he/she must reenter the selection process the next school year. Drum Majors will be selected through an audition process. Specific elements of the drum major audition process may vary from year to year.

Drill Instructors/VE Captains

Drill Instructors are responsible for maintaining field discipline as well as, studying and knowing the area of the field. When called upon, these are the only leaders to give instruction during large ensemble rehearsals. These leaders submit all required band assignments on time and at a level above the standard for others in the band.

Section Leaders/VE Lieutenants

Section leaders will be responsible for efficient operations of their sections. They will complete weekly inspections, maintain field discipline, provide instruction, serve as positive role models, and assist the drum majors as needed. They will be selected through the first portion of the Drum Major audition process.

Service Positions

All band students are eligible to apply/audition for service positions. The specific requirements for positions may vary according to the responsibilities of the office. The Vice Presidents shall assist the band directors and band students in planning, preparing, and executing various band functions. Student leadership positions range from service areas to executive areas and may change annually. Examples of student leadership positions are Vice President of Uniforms, Vice President of Administration, Vice President of Logistics, and Vice President of Events. These offices may change in name and duties from year to year. Candidates for these offices are screened through an audition process.

Band Boosters

The Rouse High School Band Boosters exist to assist the band directors in reaching the band program goals. The boosters usually meet six times throughout the year. Please check the band calendar monthly for each meeting date. The meetings are open to the public and begin at 6:30 p.m. in the Rouse High School Band Hall. Support activities provided by the boosters include serving meals to students before games, providing chaperones for trips, providing chaperones for social events, financing of social events, providing parents to assist in various aspects of the marching band production, and numerous other activities. There is a place for every parent in this organization. Your service is not only encouraged, but also needed. Band Banquet

The Head Band Director must approve any student guest who is not in the band program. Students who have left the Rouse Band program without finishing all four years are not eligible as guests to the Rouse Band Banquet. Rouse Band graduates are eligible to return to banquets as guests.

Letter Jackets

The RHS Band Letter is **first** a recognition of “***Significant Service and Dedication***” to the RHS Band Program, manifested by hours upon hours of practice, patience, and perseverance as well as sacrificial giving of time and energy for the good of fellow bandmates, the directors, and the band as a whole.

Members of the Color Guard/Visual Ensemble will use the same criteria system as the band.

A student must earn a cumulative total of 50 points to qualify for a letter jacket from the Rouse High School Band. Jackets will be awarded the following fall after qualifying permitting that the member is still enrolled in the band program.

Lastly, in the event that a senior band student has not yet earned a Letter, he/she will be awarded one from the RHS Boosters and will be welcome to purchase the jacket during the Fall Semester of the senior year, in recognition of time committed to excellence within the RHS Band Program.

Points may be earned in the following manner:

Rouse Band Participation (Maximum 25 points a year)

- Fall Semester: Successful participation in marching band season (defined below): 10 points
- Spring Semester: Successful participation in concert band or winter guard/RDC season (defined below): 15 points
- “Successful participation” is defined as
 - Marching season: maintaining eligibility and going with the band to UIL
 - Concert season: participating with the band at UIL Concert and Sight Reading Evaluation
 - Winter Guard: successful completion of the second semester, including participation in all performances and contests required by the class

TMEA All-State Band Process (Maximum 50 points a year)

- Selection to and performance with the TMEA All-State Band or TMEA All-State Orchestra: 50 points
- Selection to and performance with the 6A TMEA All-Area Band: 25 points
- Selection to and performance with the TMEA All-Region Band or TMEA All-Region Orchestra: 25 points (if a student makes both, the point total is still only 25 points)

Rouse Young Artist Competition (Maximum 25 points a year)

- Earn a Superior (First Division) Rating at the Rouse Young Artist Contest: 25 points
- Earn an Excellent (Second Division) Rating at the Rouse Young Artist Contest: 15 points

Fundraising (Maximum 15 points a year)

- Meets the minimum participation in the Rouse Booster Fundraisers (BBQ Tickets, March-A-Thon, and Wreath Fundraiser) as defined by the Director of Bands: 15 points

Region Band/Orchestra Guidelines

- All Honor Band students are expected to successfully prepare the music and audition for All-Region Band.
- All Wind Ensemble students are expected to prepare the audition material with the goal of auditioning for the All-Region Band.
- All other band students will audition by invitation only.
- The Director of Bands has ultimate discretion regarding any student participating in the All-Region Band process.
- Auditioning for the All-Region Band (an elite group) is a privilege and deserves one's best effort and preparation.
- Students will be graded on their preparation and performance of all or part of the All-Region Music, regardless of their participation in the auditions. It will count as a series of major grades, and culminate with an exam, or local/mock audition.
- Students who are selected are expected to attend all rehearsals and performances pertaining to this event. This is a TMEA Regional Event, and a distinct honor and privilege. Attendance (if selected) should take precedence over all other extra-curricular activities.

Young Artist Contest

All students are required to participate in the Rouse, local, "Young Artist Contest" preliminaries.

Grades will be issued for preparation and participation in the Young Artist Contest process. Students must use an approved accompanist. The accompanist fee is set by the band director each year. Some accompaniments are more difficult than others and may require an additional amount.

Percussion Ensemble Concert

This is a concert held in the spring featuring RHS percussionists and possibly percussionists from feeder middle school(s). The students perform music that they have learned for the Rouse Young Artist Contest as well as competition pieces for the Percussive Arts Society (PAS) International Ensemble Competition or other invitational percussion festivals. PAS is an international organization that serves the world of percussion performance and education. Membership in this organization is inexpensive and is encouraged for every percussion student at RHS.

Data Collection - Privacy Notice

The RHS Band Directors and RHS Band Booster Club use an online data information and communication website (e.g., CHARMS, BAND app, Cut Time, etc.) to keep members informed about events, practices, and other important updates. Depending on the level of access set by the director or teacher, the website may contain contact information for students and parents, directory information for students, and confidential information such as payments made, account balances, uniforms, grades, practice logs, etc. Users and administrators of the website

agree to protect the privacy of the information and agree not to use any information for non-program related purposes.



Off Campus Medication Procedures

Medication may be administered during off-campus event:

1. A parent or guardian's written request that there is a need for medication during the school day and the parent/guardian brings the medication to the designated drop-off site. This includes both prescription and over-the-counter medications.
2. All medication must be kept in a secured location and administered by trained LISD employee or trained chaperone. The only exception being any diabetic or emergency medications that have an LISD signed self-carry form (may copy/use signed form from campus clinic).
3. No medication can be dropped off or picked up/sent home by a student. Parents/Guardians must pick up all medications whether prescription or over-the-counter.
4. Over-the-counter medication must be in the original bottle or box with the label intact and non-expired. Dispensing directions regarding age, dose and frequency will be strictly adhered to. Request to alter the standard dosage or frequency on over-the-counter medication must be accompanied by a physician's written note and signature.
5. Prescription medication must be in the original container and non-expired. It must be properly labeled in a prescription bottle/box with the student's name, medication name, directions for dispensing the drug and written by a physician licensed to practice in Texas. A physician's signature is required for any dosage or medication change on prescription medication. All PRN (as needed) prescription medications will need a physician's signature.
6. Short-term prescription medication can be administered for up to 10 consecutive days without a physician's signature. The prescription label can be no more than 7 days old upon receipt by the school clinic. A written request/signature from a physician must be obtained if the medication needs to be administered for more than 10 days.
7. Medications (controlled substances) will be counted by either a trained LISD employee or trained chaperone upon arrival at drop-off site and documented as to the number of pills received. Narcotic pain medications prescribed for temporary medical conditions will not be stored or administered. Medications must be delivered by the parents/guardians.

8. A student may be allowed to self-administer inhaled asthma medication, an Epi-pen, or diabetes treatment ONLY if the following conditions have been complied with: a. Written permission from the physician allowing the student to self-medicate or treat b. The nurse has counseled the parent and the student on the school's inability to monitor the student's health condition during the school day while self-medicating or treating c. The student complies with all campus safety policies
9. No district employee or trained chaperone will administer herbal substances, anabolic steroids or dietary supplements except as prescribed by a physician if it is required by the IEP or Section 504 plan of a student with a disability. Medication must be provided by student's parent or guardian. Reliable information must be given by the physician regarding the safe use of the product including side effects, toxicity, drug interactions and adverse effects.
10. It is the responsibility of the parent/guardian to ensure all health/medical and medication information is current as of the day of the off-campus event.
11. All private health information (PHI) will be stored in a secure location when not at an off-campus event. When information leaves the housing campus for an off-campus event it will be signed out by a LISD staff member or trained chaperone. That person is responsible to keep PHI secure & confidential during the event, then sign-in & return information to housing campus when event is over.

COVID-19 Addendum

The information contained in this handbook will be invaluable to students and parents as you participate in one of our outstanding LISD Fine Arts programs. Much of the information you will read and to which you will acknowledge an understanding of is based on a normal academic year.

However, the COVID-19 pandemic has created a situation that makes it difficult for teachers to prepare for and communicate precisely how certain aspects of the program will operate. Flexibility will be a key component to the success of our students during the 2020-21 school year. As a result, it may be necessary for adjustments and updates to be made to the information in this handbook, at which time our teachers/directors will do their utmost to communicate these adjustments as quickly and clearly as possible. Should you have a question or concern about the changes to the enclosed guidelines, I encourage you to contact the appropriate director at your earliest opportunity.

 - Suspension from performances or band activities
 - Loss of varsity/primary marching status or lowered band placement in concert season
 - Probationary placement within the program
 - Removal from the band program
- *Behavioral* incidents may additionally be referred to campus administration for disciplinary action on a campus level.

PARENT/STUDENT MARCHING BAND REHEARSAL & PERFORMANCE AGREEMENT FORM

All students and parents will agree to the rehearsal schedule posted on the www.rouseband.org band calendar. All rehearsals are mandatory. Every student of the Rouse Band is committed to attending and fully participating in all rehearsals and all performances throughout the marching band season

Examples of marching band rehearsals:

- Marching Band Rehearsal (both full band and components)
- Any Marching Band Group Instructional Activity
- Debriefing and Viewing Marching Band Videos
- Playing off Marching Band music
- Clinics for the Marching Band or any of its components.

Missed rehearsals or performances will result in the following consequences

- Role change to a Junior Varsity performer
- Suspension from football game performance
- Suspension from contest performance
- Band placement change
- Possible removal from the band program

NOTE: Rehearsal and performance schedule on the band calendar in May of the semester prior. All students are expected to maintain understanding of the band calendar through use of the band calendar available at www.rouseband.org.

PARENT/STUDENT MARCHING BAND ACKNOWLEDGEMENT FORM

No student may be required to attend practice for marching band for more than eight hours of rehearsal outside the academic school day per calendar week (Sunday through Saturday). This provision applies to students in all components of the marching band.

On performance days (football games, competitions and other public performances) bands may hold up to one additional hour of warm-up and practice beyond the scheduled warm-up time at the performance site. Multiple performances on the same day do not allow for additional practice and/or warm-up time.

Examples of activities subject to the UIL Marching Band Eight Hour Rule:

- Marching Band Rehearsal (both full band and components)
- Any Marching Band Group Instructional Activity
- Breaks
- Announcements
- Debriefing and Viewing Marching Band Videos
- Playing off Marching Band music
- Clinics for the Marching Band or any of its components.

The following activities are not included in the eight-hour time allotment:

- Travel time to and from rehearsals and/or performances
- Rehearsal set-up time
- Pep rallies, parades and other public performances
- Instruction and Practice for individual activities such as All-Region/Area/State try-outs and Solo-Ensemble preparation
